Whereas a complaint dated 17-09-2010 has been received in this office from Sh. Om Prakash S/o Sh. Hari Chand, Vill. Bassa, P.O.& G.P. Chhatar Jogiyan, Teh Nurpur, District Kangra and whereas the same was sent to B.D.O. -cum-P.O (MGNREGA) Nurpur vide this office no. Ombudsman-134 dated 18-09-2010 with the direction to conduct the inquiry within seven days and whereas the B.D.O. -cum- P.O. MGNREGA has though conducted the inquiry on 01-10-2010 but has not submitted the fact finding inquiry report and whereas the complainant has again requested vide application received in this office on 13-10-2010 to conduct the inquiry at the level of Ombudsman to provide justice. Therefore, further inquiry is fixed on 26-10-2010 at 11:00 A.M. . You are therefore directed to attend the same/ authorise your representative along with record to present documents relating to complaint. You are also advised to direct the concerned Pradhan and Secretary G.P. Chhatar Jogiyan, concerned ward Panchs, Panchayat Technical Assistant/ Junior Engineer to attend the inquiry. Besides, Secretary of the Panchayat may be directed to bring original mustrolls, measurement Book, Stock register of material purchased, cheque books- Payments vouchers and other information regarding conduction of Social Audit by the Gram Sabha in respect of developmental works executed under MGNREGA. You are also directed to bring the record of Monitoring/ inspection of MGNREGA work done by you and technical staff in the said Panchayat since the inception of MGNREGA scheme.
